## RULES

Entries will be accepted via email ([info@campnj.com](mailto:info@campnj.com)) between May 22 - October 31, 2023.

The contest is open to any amateur photographer. An amateur is defined as someone who does not earn the majority of his or her living from photography. NJCOA campground members along with their employees and members of their immediate families are ineligible to enter.

- Photos must have been taken at a New Jersey campground during the 2023 camping season and should reflect your New Jersey camping experience.
- Eligible format is high-quality digital images from hand held cameras, cellphones, smartphones, or game cameras.
- File size should be between 2MB to 10MB. A large file size is required for printing quality.
- Photographers may enter up to 2 photos total.
- Each photo must be accompanied by a completed **Submission Form (page 1)**. Any photo submitted without a Submission Form and/or an incomplete form will not be accepted.
- Submitted photos must include a **Model Release Form (see page 3)** for any persons recognizable in submitted photo. Any photo with recognizable persons submitted without a Model Release Form and/or an incomplete form will not be accepted.
- Minor adjustments of color/contrast, sharpening, spotting, dodging and burning are acceptable.
- Photographs manipulated for artistic purposes by applying special effects such as HDR, collage or photo composites will be disqualified.
- Images with borders, watermarks, dates, and names will be disqualified.
- Judges will make selections based on quality, composition, content, originality, uniqueness, creativity, and general appeal.
- If your photo is selected, it may have the opportunity to be used in the 2024 New Jersey Campground & Outdoor Lodging Vacation Guide, on social media, NJCOA website, and/or any other medium NJCOA sees fit to help promote camping in New Jersey.
